- Shipments requested to be removed from the cargo facility after acceptance will be subject to all applicable terminal handling charges.
- Any undeclared Firearms/ammunition will be treated as Section 5.
- Any undeclared Dangerous Goods shipments will need to be removed and represented. Check fees and security charges will be charged twice.
- A surcharge applies to all payments made by Debit/Credit Card
- A late payment charge of 3% will apply if payment not made after 30 days from invoice date this will be on the full invoice not prorata.
- A surcharge of 5% on the amount paid applies to all cash payments and is payable immediately.
